Dear Vincent I. White,

This document is for public release based on our past discussions around forming a joint operating company with Hershel Daniels Junior LLC (HDjLLC). The enterprise HDjLLC which was created as a family office company that this Juneteenth became the center of creating 1,000 partners for development in 2024 based on the statement, I, Hershel Daniels Junior, made at the second session of the United Nations Permanent Forum on People of African Descent in an official side event on May 30TH 2023.

That statement read, "Friends of the African Union will propose Reparatory Justice for People of African Descent for the history of the 34M in the global African slave trade from the 7th century AD though 1962. This Black Folks Plan Reparatory Justice Update of 2023 was originally proposed at the Commission on the Status of Women 67th meeting with unveiling of the \$75 Trillion Global Compact for Democracy with a #JustEconomy to Pandemic Proof the World using the Daniels IDIQ, over \$620B in bank based community benefit agreements created since 2016 and the 7 Pillars of Social Justice with African Capitalism."

The United Nations Permanent Forum on People of African Descent was created by the United Nations General Assembly on August 2nd, 2021, as a consultative organization to the UN on 1/5 of the human population, 1.6B plus People of African Descent. Friends of the African Union, a Hershel Daniels Junior LLC client, has been reconfigured in support of this organization and the people it serves. Hershel Daniels Junior LLC will support the Friends of the African Union proposed global Reparatory Justice for People of African Descent through the 1,000 partners based, in part, on the Community Benefit Agreements (CBA) it is a signature to currently such as the 4 year (2022-2025) \$88B PNC Bank CBA and as a member of the National Community Reinvestment Coalition who has created over \$620B of these CBA's with 27 Federal Reserve Banks since 2016.

This Black Folks Plan Reparatory Justice Update of 2023 which was originally proposed at the Commission on the Status of Women (CSW) 67th meeting was put forth by me as a He for She proposal using a business process framework called the Friends of the African Union smartWISE Community Reinvestment Coalition(s). HeForShe was founded by United Nations Women as an invitation for men to stand in solidarity with women to create a bold, visible and united force for gender equality.

I do that through the CSW. HDjLLC will by CSW 68 in 2024 have created around the world 1,000 development coalitions based on the above work with each ready for our joint work. We start with the Friends of the African Union Uganda Bureau in this later this month based on the following pages.

In doing this work I stated that in actions carried put during Friends of the African Union Juneteenth Week 2023 (June 12th through June 17th, 2023) that I planned to form with CETS to technology joint ventures to address climate change.

The first is creation of a global interdisciplinary design firm that will merge the disciplines of architecture and engineering into a professional practice joint venture that employs one or more licensed architects, with you being the principal Architect and that offers a comprehensive set of architectural services. With my company as sales and development manager it would build its operations as a leading industrial and architectural designer of 21<sup>st</sup> century environmental ecosystems that support Net Zero systems solutions in real estate development with a focus on low moderate income housing, health care facilities of all types including retirement, schools and education facilities sports and recreation facilities, public and private.

This company principal owners Hershel Daniels Junior LLC and CETS will create development partnerships around the world as we develop this global business. Although we start operations this day in the United States our global scope of business includes Sierra Lerone, The Gambia, Samoa, Canada, Uganda, Kenya, Senegal, Liberia, Guinea, Nigeria, Cameroon, Zimbabwe, South Africa, South Sudan, Ethiopia, Somalia, Republic of the Congo, Ivory Coast, Tanzania, Democratic Republic of the Congo and nations in Europe with people of African Descent such as the Ukraine, Ireland and England.

This letter serves to provide a framework for Hershel Daniels Junior LLC and CETS to work together collaboratively as developmental partners on a variety of projects including projects to be developed in 2024 in the above named counties based on the FAU smartWISE Community Reinvestment Coalition model and the CETS Global Carbon Emissions Reduction Program Digital Ledger Blockchain Circular Economy platform and our agreed upon strategy to activate work with the D9 and ASI Fellowship.

Second, today, June 19<sup>th</sup>, 2023, I am writing to express our intent to form though the above company with Friends of the African Union, UNESCO Center for Peace, Ateker Kingdom Alliance, and the BIPOCA ALLIANCE in a joint venture with CETS Technologies (CETS) to implement CETS's Global Carbon Emissions Reduction Program – Transitioning to a Digital Net-Zero Supply-Chain Management Protocol by 2050.

Today on June 19<sup>th</sup>, 2023 (Juneteenth day 2023) we announce the first Friends of the United Nations Permanent Forum on People of African Descent Climate Change Conference on November 28<sup>th</sup> 2023.

It will be a side event to the Conference of the Parties to the United Nations Framework Convention on Climate Change (UNFCCC) more commonly known as COP. It is used by governments to agree on policies to limit global temperature rises and adapt to impacts associated with climate change. At COP28 the world will assess and drive progress on combating climate change.

The Friends of the United Nations Permanent Forum on People of African Descent Climate Change Conference will be the first such event that is based on the 1.6B people represented by the United Nations Permanent Forum on People of African Descent.

It is to be held as a Hybrid global event using the C7ISR3 platform just before the 28th United Nations Climate Change conference from November 28th through December 12th, 2023. It will follow our proposed work at the Africa Climate Summit being co-hosted by the Government of Kenya and the African Union Commission on 4th to 6th September 2023, and is co-convened by the African Development Bank and Global Center on Adaptation (GCA). The Global Center on Adaptation is collaborating with a range of partners from across the public and private sectors, including multilateral institutions such as the European Bank for Reconstruction and Development (EBRD), to drive the mainstreaming agenda.

The work presented at the Africa Climate Summit is being developed through the joint leadership provided Hershel Daniels Junior LLC, Friends of the African Union, UNESCO Center for Peace, Ateker Kingdom Alliance and CETS Technologies in the creation of a updated Global Carbon Emissions Reduction Program – Transitioning to a Digital Net-Zero Supply-Chain Management Protocol in line with the African Union's Agenda 2063, the UN Sustainable Development Goals and the #BlackFolksPlan.

The creation of the Global Compact for Democracy with a #JustEconomy to Pandemic Proof the World (Global Compact for Democracy) at COP28 will use the Daniels IDIQ and be driven by the \$40T Black Folks Plan global plan for People of African Descent. The Global Compact for Democracy involves the creation in 2024 of 1,000 partners committed to invest assets valued at \$1B USD a year for a 75 year term based on our past work at the US Federal Reserve, the African Union and the United Nations with the Universal Periodic Review in the creation of a global Net Zero world.

We do this work as a sponsor of an official side event of the United Nations Permanent Forum on People of African Descent on May 30th 2023 by Friends of the African Union, UNESCO Center for Peace, the World Conference of Mayors Committee on the United Nations Permanent Forum on People of African Descent, the Sons and Daughters of Africa, the Ateker Kingdom Alliance, International Multiracial Shared Cultural Organization and allies such as Northeast Ohio Neighborhood Health Services proposed a solution for Reparatory Justice for People of African Descent driven by the \$40T Black Folks Plan.

This Black Folks Plan Reparatory Justice Update of 2023 was originally proposed at the Commission on the Status of Women 67th meeting with unveiling of the Global Compact for Democracy which will use a global payment system driven by the African Dollar in 21st Century African Capitalism.

This work is based on our experience as a member of a 34 year old 700 member National Community Reinvestment Coalition in creating over \$620B in Federal Reserve Bank community benefit agreements created since 2016 and now in 2023 with the 7 Pillars of Social Justice as licensed to be used in the Friends of the United Nations Permanent Forum on People of African Descent as the overseer of the proposed 75 year Global Compact for Democracy process.
